<u>Option A</u>: Attend the Vendor Fair on January 25; 8 ft table display/space (\$275). *All registration* & *payment received by November 30<sup>th</sup>, 2016 receive a \$25 discount (reduced rate \$250).* <u>Option B</u>: Display a booth for the entire 3 day conference (\$500). *To attend the conference and arrange lodging you must register directly through Sandy Cove.* 

<u>Option C</u>: Provide us with a print piece for the Welcome Packet each attendee receives; ~250 pieces; exhibitor covers shipping costs (\$75).

<u>Option D</u>: Send materials for a shared information table in the vendor area - no reps present; exhibitor covers shipping costs (\$50).

Option E: Provide an advertisement slide shown before & after general sessions (\$50).

If you have other ideas of how you would like to be involved not listed under these options, send me an email. For example you could provide a side dish, dessert or the main entrée for a meal.
